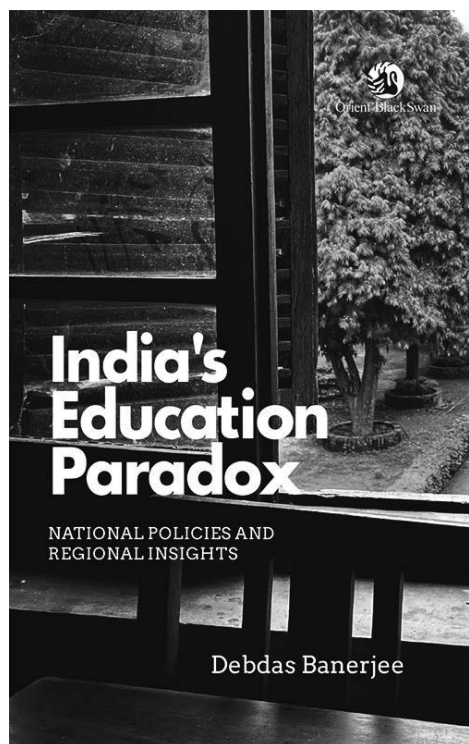
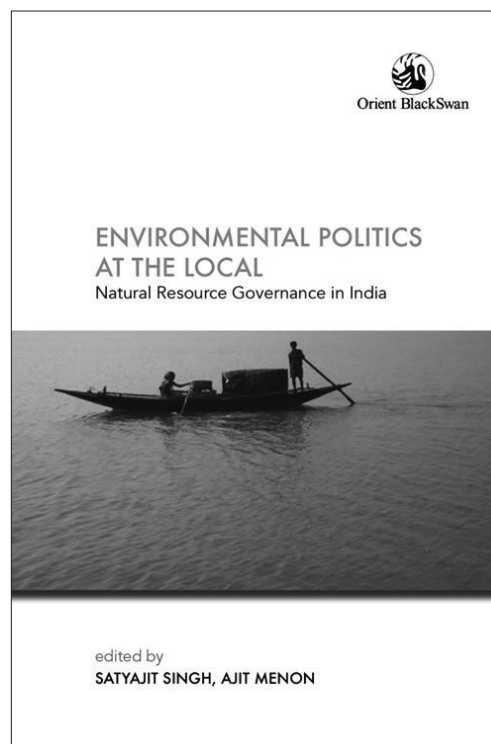

Education is a human right; however, in India, education contributes the most to the overall inequality index. *India's Education Paradox* mounts a critique of this situation and the falling standards of education in India, contesting the constructs of 'inequality' and 'efficiency' in education with the help of alternative paradigms. Using recent data, the volume offers insights into policies centred around the 'capabilities' approach, the dilemma between education as a public and as a private good, neglected aspects of fiscal policies and federal issues in opportunity creation, and a comparison of the vocational systems of countries with diverse systems of government.
